

### Dallas-Fort Worth Dachshund Club's 70<sup>th</sup> Anniversary Year Obedience & Rally Extravaganza

3 Obedience & 3 Rally Trials over 2 Days – June 20, & 21, 2015 Reporting by Sandi Myers, Trial Secretary

The setting is the Dog Training Club of Dallas County in Duncanville, TX, a great training facility located in a southern suburb of Dallas. This is the third year the Dallas-Fort Worth Dachshund Club has held their annual 3 obedience & 3 rally trials for dachshunds-only. There were 70 entries total (25 rally & 45 obedience) which is very fitting for celebrating our 70<sup>th</sup> Anniversary year. DFWDC offered all of the regular rally and obedience classes, all of the optional titling classes, plus non-regular classes of brace and veterans. We had no non-regular entries this year. What a year it was...

The first rally trial had 8 dachshunds entered from 6 owners, trial #2 had 9 dachshunds entered from 7 owners, and trial #3 had 8 dachshunds entered from 6 owners under judges Pat Gannon (#1) and Rose O'Hara (#2 & #3). There were 21 qualifying runs in rally with 6 new titles for the weekend. This is an 84% pass rate, up 21% from last year. The largest rally class with some challenging courses, the Excellent B class, had a 100% Qualifying rate.

In obedience, the first trial had 14 dachshunds with 17 entries. At the second trial there were 12 dachshunds with 14 entries. At the third trial there were 12 dachshunds with a total of 14 entries. Our judges were Pat Gannon (#1 & #2) and Jim Merchant (#3). There were 20 qualifying runs out of 36 in obedience with a 56% pass rate (9 entries were absent). Gene Morris & Zeke retired the High In Trial Challenge Trophy for the third time in a row, they also won High Combined at the second & third trials. The DCA 2<sup>nd</sup> High In Trial went to Sandi Myers & Mr. Tali (from Novice B) at the first trial on Saturday and Kathie Reid & Jack earned the 2<sup>nd</sup> HIT DCA medallion at trial #2 on Saturday (from Open B).

Exhibitors were entered from 3 states (Iowa, Louisiana, & Texas); however, the exhibitor from Louisiana was unable to participate due to illness. Entered in the trials were 7 mini longs, 4 mini smooths, 2 mini wires, and 3 standard longs. Rally titles earned were 2 RNs, 1 RA, 3 REs. Obedience titles earned were 3 CDs. One exhibitor's dachshund earned his UDX9 at a show right before our show, so he earned 2 legs on the UDX10 while at our show.

A special thank you to JoAnne McCraw for donating all of the High In Trial and High Combined dachshund plate trophies of which Gene Morris & Zeke won them all for a nice luncheon set! DFWDC also gave all exhibitors our now traditional swag bag (a swag container this year) in place of trophies (everyone goes home with something). The swag container had handmade dachshund-shaped soap, a hand quilted dog bowl mat, toys, notecards, cold pack, lucky pin, a screen cleaning cloth and free room night compliments of Red Roof, and homemade dog treats. Each exhibitor also received the 70<sup>th</sup> Anniversary Logo pin (if they had not already received one for an event earlier in the year). All contributors to the swag were given a listing in the catalog. We also advertised all of the 70<sup>th</sup> Anniversary donors with a separate listing for those who donated specifically toward Obedience & Rally. Several people purchased ads in the catalog.

Of course we could not have a smooth running event without the Committee and the volunteers who stewarded, helped set up and provide lunches both days (our Salad Buffet is becoming famous), ring set-up/take down, those attending for moral support & cheering squad, and clean up at the end of the trial. Thank you to everyone who helped.

The rings were decorated with the 70<sup>th</sup> Anniversary glitter dachshund cut-out streamers that were made for the conformation show. They added a festive look along the outside of the front ring gates facing the audience. Ken Hagmueller & I provided a celebratory half vanilla, half chocolate, sheet cake with the 70<sup>th</sup> Logo airbrushed in the buttercream icing. All of the lunch buffet items were delicious (as usual), some club members bringing a salad dish & dessert both days. All in all another successful event. Time to start planning for 2016.
